We are working to improve our follow up system for when someone exits our local detention center either by having served their time or by being transferred, we still attempt to have a relationship with those who are our brothers and sisters in Christ. This highlights the importance of not only obeying the Gospel, but by strengthening one's faith daily once they have been baptized. Paul Sain, in his resource entitled, "*Ready Reference for Growing Christians, Facts & Scriptures on 100 Biblical Subjects*," directs us to what God expects after baptism. We share this resource with those inmates who have been baptized.
